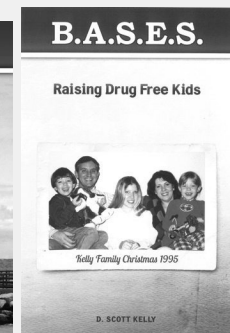
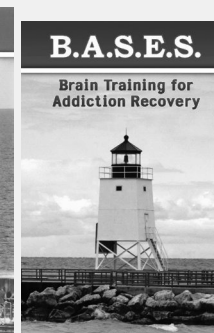
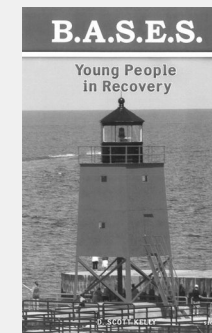
Outpatient counseling for adolescents and adults
